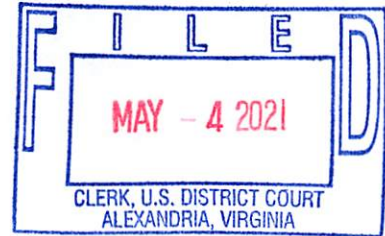

MOTION TO REMAND

Plaintiff Paul Shao hereby moves this Honorable Court, pursuant to 28 U.S.C. §1332(a) and §1447(c) to remand this action to the Circuit Court for County of Fairfax, Virginia in consideration that an agreement has been reached between Paul Shao and Mr. Scott Humphrey of SEYFARTH SHAW LLP, the outside and lead attorney for the defendant, Allstate Insurance Company. The agreement is that, if Paul Shao consented to do a Declaration, stating that his demand is equal to or less than the sum of \$70,313.33, Defendant would agree to remand the case back to the Circuit Court. 

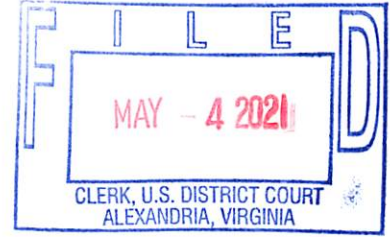
